"On the Law (Part Six)"

What We Can Do

When it comes to obeying God's law, it seems a simple thing. He says do it, so you do. He says don't do it, so you don't. Yet, it is not that with which we are in agreement that we have a problem, it is against that which we find difficult or unimportant or inconvenient that we tend to rebel. Again, God's grace is for those of us who try and fail.

- But what grace is found for those who don't care?
- Or those that don't try?
- Or those out of rebellion, who don't even make attempt to find that they are in transgression?

Let us try and fail. It is better than not trying at all.

The tithe is such a good example of God making a stiff requirement of us that is thoroughly fair and can be universally applied. It requires 10% of what we have been given or "from our increase." It makes no demand upon those who have nothing and makes fair demand upon the ones who have. If it were a predetermined fee, the amount could be considered a pittance to the rich while the same amount would be a fortune to the poor. But he made it perfectly fair. He didn't require it from folks who no longer had it because it was spent, nor did he require it in advance of receiving it; the tithe was due at the time that the increase occurred. One can find no suitable reason not to tithe. It is fair, timely, and affordable. It is something that we can do. But should we? When someone asks, why should we tithe, I must ask, why not? The only reason I can think of not to tithe is, I would rather have my money than give it away.

Bad reason -- I'll tithe.

Let us digress for a moment to the subject of the innate desire to serve or prove our faith. This answered for me a quandary proposed by those who think tithing was an Old Testament doctrine that has no place in modern Christianity. They say one tenth is not enough. They say, "We are to give all not just a tenth." After all God gave His only Son to you and therefore we should be willing to give everything to Him. Well, this is a touching sentiment, and it probably will sound good through a speaker system, but can we to bring that idea to fruition? How are we to know that we have been obedient? How is one to carry out such a ludicrous doctrine? How are we supposed to know that we have done that which is our duty to do? Our assurance comes from knowing that if the Lord wanted 40% that He would have said so. If he wanted 60% or 80% or 110% He would have said so. But that is not what He said. He said 10%. I say, "Thank you Father, for making it so plain. - I'll tithe."

Remember the error of Cain. Both of the brothers made sacrifice. Both gave, one God's way - one his own way. No mention was made in the story about the amount of Cain's sacrifice, or of Abel's. It is our creaturely greed and pride that make us think in terms of quantity. "The bigger the better," we say. **God is not looking for His bank balance to increase; He is looking for an obedient people**. We must do what He asks, because what we want, no matter how motivated, or how it is initiated, is still what we want. We think quantity, while He seeks quality.

If we approach the law with the attitude that we will do whatever we want to do, only that which benefits us will be done. If we approach the law with the attitude that we will do whatever we can do, there will be a lot more done than anyone can realize. Think of the money problems that would virtually disappear if we simply took on the tithe as something we want to do. Think of the alleviation of debt that we would enjoy if we lent money WITHIN the Church at no interest and practiced the year of jubilee and the years of release. No doubt, as the Scriptures in the footnotes are read, there will be those who say

that they never knew these Scriptures were in the Bible. But they are there ... in your Bible; and most of them are easy to understand and to follow.

If we approach the Old Testament as a revelation into the mind and personality of God, and not as an antiquated rule book for the Jews, we will be more compelled to find ways to obey. Some of these things are easy and some will make drastic changes in your lifestyle. Some will add to your financial acumen and some will cost you more than you may be willing to pay. I am sure all the laws will effect people differently, but if we can do it, we should do it -- let's approach obedience to the law with the attitude: if I can I should.

It is not only the Law of the Old Testament that has something to offer, the prophets are equally rich. When I read the prophets who spoke for God and listen as they delineate the concerns that He has, I see a way to please Him. Example: Exodus 23:13, "And in all things that I have said unto you be circumspect: and make no mention of the name of other gods, neither let it be heard out of thy mouth."

This was the motivation for Quakers not to use the god's names for the days and months. They insisted on using the Bible names such as First day instead of the Sun-day named by Constantine in 325 AD for the venerable day of the Sun.

I thought to myself, "I can do this." I can do this for the lover of my soul. If He doesn't like me to use the names of other gods, I won't. One may say that it is unimportant, but according to Scripture, it is important. One may think that grace is in place for things like this. This might be true if you had no Scriptures to tell you differently. But we can do this, and we should.

There is a host of things we can do to bring our lives into line with the Scriptures.

- Why do we not at least try?
- Can we be faithful to Truth if we don't even try?

What We Cannot Do

As one looks at the Law, one will inevitably come to a point that goes against what the Spirit of Christ has placed in our heart.

One of the particulars of the law with which I have found difficulty is the part that requires the death penalty, i.e. disobedient children. In those days, even adultery was punishable by death. How are we to obey these laws? First, I think we should gain the understanding of the severity of these offenses. These are not "natural" offenses to be overlooked and pardoned, but sins to be dealt with severely. To miss that fact is a mistake in itself. Also, there are differences today that make these things difficult to enforce or practice. One difference is that God is not speaking to us today by Prophets and Apostles and burning bushes. He now has spoken to us by His Son who has made mercy plain to us and has mandated forgiveness. This is not to say that we are to tolerate sin, but rather to say that we are to leave judgment to God. On one occasion, the Apostle Paul gave some to Satan for their destruction. The understanding of this must come from being an Apostle, for I do not pretend to have it.

We also must understand that condemnation is not for us to effect upon the world. Even as Christ was not willing to condemn a world that was condemned already, we should not be so quick to do so. *We are all living under a death penalty and in need of appeal.* Without God to say publicly, "stay now thine hand." It is not the duty of Christians to execute the lawless. This is something I feel I cannot do. Some things in the Law we simply will not have clearness to perform. These are things we cannot do. We should never go against a clear conscience. Some will argue that if one does not carry out the letter of the Law they are breaking the law. This cannot be true for we see Christ forgiving rather that executing one adulterer caught in the very act.

Here are some things we cannot do:

- We cannot redeem ourselves.
- We cannot live in such a way so as to affect our own salvation.
- We cannot do so many good things that God will say, "Well done thou good and faithful servant."
- We cannot "lay-up" good deeds to counteract the bad deeds and effectively earn a place in the Kingdom of God.
- We cannot please God as Christ did.
- Nor can we go on with our lives doing whatever we want and expect that we are pleasing God, never considering whether or not our lives fall within the divine Law, or how our lives conform to His divine will.

What a wonderful expression of devotion is a life conforming to God's divine Law. "Oh how love I thy law," the Psalmist writes. How many of us can say that in sincerity? Today, we must use the law as an avenue of understanding God's way and guiding us down a path of obedience that can only make our Christian life more fulfilling and rich.

Consider the instruction Paul gave in 1 Timothy 1:8, "But we know that the law is good, if a man use it lawfully"; Let us use it lawfully, and not expect to be justified by anything other than the precious blood of Christ. Let us use it lawfully to show us how to live in His constant pleasure.
